SMV WI Software License Agreement

Important

Read this entire agreement carefully before opening and/or using the software. By opening and/or using the software, you indicate your acceptance of the following Software License Agreement.

This software license agreement is a legal agreement between you and Kernel Software, Inc. By opening the sealed software packages and/or using the software, you are bound to the terms of this agreement. If you do not agree to the terms of this agreement, return the unopened software packages and any accompanying items to Kernel Software, Inc. within thirty days of purchase for a full refund.

Grant of License

This License Agreement permits you to use the SMV WI software only on computers operated for or by the Wisconsin SMV provider designated by the Wisconsin Department of Health and Family Services provider number embedded in your copy of the software. No other provider or agent of another provider may use your copy of the software.

As a licensee, you and your agents are granted the right to modify the SMV WI software, provided that the modified software is for your own use. Any other use or resale of the modified software or any of its components is expressly forbidden. In addition, Kernel Software, Inc. retains the right at its discretion, to inspect and to incorporate into its product, any and all modifications made by the licensee or its agents. The licensee and its agents shall deliver to Kernel Software, Inc. within thirty (30) days of its request any and all modifications made to the SMV WI software.

Description of Other Rights and Limitations

You may not reverse engineer, decompile, or disassemble the SMV WI software or its components, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation or is expressly permitted by this agreement.

You may not modify or in any way alter that portion of the SMV WI software, which restricts your use of the software to the SMV transportation provider for which the license was purchased.

The SMV WI software is licensed as a single product. Its component parts may not be separated for use in any manner inconsistent with this agreement.

You may not rent or lease the SMV WI software.

You may permanently transfer all of your rights under this agreement only as part of a sale or transfer of your business to another Wisconsin SMV provider under the restrictions you retain no copies of the SMV WI software, you transfer all of the SMV WI software, and the buyer agrees to the terms of this agreement.

Without prejudice to any other rights, Kernel Software, Inc. may terminate this agreement if you fail to comply with the terms and conditions of this agreement. In such event, you must destroy all copies of the SMV WI software and all of its component parts.

Copyright

All title and copyrights in and to the SMV WI software (including but not limited to any forms, reports, code, icons, and images incorporated into the SMV WI software), the accompanying printed materials, and any copies of the SMV WI software, are owned by Kernel Software, Inc. or its suppliers. The SMV WI software is protected by copyright laws. You may not copy the printed materials accompanying the SMV WI software.

Product Support

Product support for the SMV WI software is provided only under a separate agreement. Training, technical support, maintenance, and upgrades are not included with the purchase of the SMV WI software.

Limited Warranty

Kernel Software, Inc. warrants that the SMV WI software will perform substantially in accordance with the accompanying written materials for a period of thirty (30) days from the date of receipt.

Customer Remedies

Kernel Software, Inc.'s and its suppliers' entire liability and your exclusive remedy shall be, at Kernel Software, Inc.'s option, either return of the price paid or repair

or replacement of the SMV WI software which does not meet the Limited Warranty. The Limited Warranty is void if failure of the SMV WI software has resulted from accident, abuse, or misapplication. Any replacement SMV WI software will be warranted for the remainder of the original warranty period.

No Other Warranties

To the maximum extent permitted by applicable law, Kernel Software, Inc. and its suppliers disclaim all other warranties, either express or implied, including, but not limited to implied warranties of merchantability and fitness for a particular purpose, with regard to the SMV WI software and any accompanying written materials.

No Liability for Consequential Damages
